BY-LAWS

Section 1

All persons desiring to join the club must do so as a Social Member. Applications shall be presented to a Club Officer. The prospective members must attend two Business Meetings and/or alternative attendance requirements as specified under Associate Member requirements and then be voted on at the third Business Meeting by secret vote. The prospective member must meet these three attendance requirements within a six-month period. Prospective Social Members must be present at the meeting when they are voted on for Social Membership. Three negative votes shall deny Social Membership. Membership privileges are the same as for Associate Members, except that they are not eligible for Full Membership.

Applicants for Associate Membership will only be taken from existing Social members under the following conditions:

*They must have been an active Social Member for at least one year

*They must attend eight of the twelve previous Business Meetings.

OR

If unable to attend Regular Business Meetings, Associate Members may elect to be present monthly (only once per month) on Sundays for a minimum of four (4) hours in lieu of a meeting. An Associate Member may also elect to work any social event, i.e. Round Robin, Memorial Shoot or

organized social event, This will not count towards required yearly work commitment nor be a paid workday

OR

A combination of eight per year of the above.

Application will be allowed only at the February or August Business Meetings

Associate Members are required to make eight of the twelve Business Meetings or alternate attendance requirements per year.

Associate Members are responsible for documenting their attendance and work hours as specified when they declare associate membership.

Members must be present at either the February or August Business Meeting to be voted on for full Membership.

They must fulfill their yearly work commitment per year.

They are not eligible to vote or have a key to the Clubhouse.

After one year as an Associate Member, one is eligible for full membership if roster space is available. If eligibility for is not maintained, membership will automatically be reverted to social membership. Eligible applicants shall be voted on by secret vote at a February or August Business Meeting. Three negative votes shall deny Full Membership. Associate Member status may be continued and application for full membership re-submitted at the next opportunity.
